Pavilion Rental Reservations

Reservations for 2018 begin on Tuesday, January 2nd for inperson rentals only starting at 8:00 a.m. at City Hall. Beginning January 3rd, the City will start accepting reservations by email with payments taken by phone along with walk-in reservations. The Picnic Grove, Island, Volleyball Court and North Lake Pavilions are reserved on a "first-come, first-serve" basis.

Please make sure your application is filled out completely before making your reservation at City Hall on January 2nd. Payment is expected in full at time of reservation.

- Submit your application in one of two ways:
 - At City Hall, 100 W. Woodstock St., between 8:00 a.m.-5:00 p.m.

A PLACE FOR WEARY TRAVELERS

It's hard to imagine today's Route 14 (Virginia Street) as once being an old Native American trail which connected Fort Dearborn (Chicago) and Wisconsin. As settlers arrived in the 1830s, their wagon and cart paths followed the naturally worn trails of their predecessors.

The original Plat of Survey for the Village of Crystal Lake was completed in 1840. This original Plat indicates eight streets and twelve city blocks. One of the original eight streets was King Street which intersects with Virginia Street near today's McCormick Park.

King Street is named after one of Crystal Lake's earliest settlers. Lyman King was born about 1783. He came from New York State to Crystal Lake in the late 1830s with his second wife, Phoebe Williams King. The Kings were cousins to at least two other early Crystal Lake families, the Beardsleys and the Lampheres.

Lyman was a farmer and a business man. The King family was very active in their church and community. Upon arriving in Crystal Lake, Lyman helped to build the first school house. The school was built of logs and was located at the northwest corner of Virginia Street and McHenry Avenue. On May 24, 1840, Lyman and Phoebe were the first people to be "received by letter" into the Crystal Lake Baptist Church. Their daughter, Fidelia, was the first child baptized in the church.

Lyman King owned several city lots on Virginia Street, where he built the King Hotel. The hotel was first constructed of logs. Later, the interior dining room was embellished with walnut beams and plastered walls. The King Hotel was a favored stopover of stagecoaches and fur traders. Horse teams were changed, mail dropped off and picked up, and travelers walked around and refreshed themselves until the driver blew the whistle announcing to all within earshot that it was time to head onward. The King Hotel was located across from the City Park, approximately where the Taco Bell stands today.

In 1913, William Beckman of Sacramento, California wrote a letter which was published in the Crystal Lake Herald. Mr. Beckman recalls, "In 1848 John Frink & Co., the great stage company of that day, established a stage line from Chicago to Beloit, Wisconsin, which passed through Crystal Lake. The distance from Chicago to Woodstock was 51 miles, and in good weather I used to make the trip in about nine hours, and in bad weather it took from twelve to fourteen hours. I was only 16 years old, and was the youngest stage driver that was employed by that company. We used to stop and water the horses at Crystal Lake. There was only one hotel there, and it was kept by a very congenial gentleman."

After Lyman's death in 1851, the King Hotel changed hands several times. The 1860 census shows James T. Bradley as the innkeeper. The Bradley family and two domestic workers lived and worked at the hotel. An early newspaper article indicates that Mr. Bradley added the upright (second floor) to the hotel.

In 1870, the hotel was purchased by T.H. and Huldah Ashton and was thereafter known as The Ashton House. Ashton enlarged the original hotel structure by adding on several additions. The Ashton House was called the "Grandfather of all Hotels" and was one of the largest, most elegant buildings in the vicinity.

After the death of T.H. Ashton in 1891, Huldah Ashton and her three daughters continued as innkeepers of The Ashton House.

On November 13, 1904, The Ashton House caught fire. The fire was first discovered about 5 o'clock in the afternoon. An alarm was sounded, and neighbors rushed to help the family save the furniture and household belongings. Incredibly, most of the furnishings in the fifteen bedrooms, dining room, and kitchen were carried out of the burning building. Volunteers used wet rugs, bucket brigades, and any other means to try and put out the fire.

Sadly, the hotel that had welcomed guests and provided a resting place for weary travelers for nearly 70 years was lost to the flames and was never rebuilt.



FIRE RESCUE DEPARTMENT



"KEEP THE WREATH RED"

It is Holiday season again! The Crystal Lake Fire Rescue Department, with the Illinois Fire Chief's Association, is participating in the "Keep the Wreath Red" program. The program is a reminder to practice safety precautions during the holiday season.

To prevent holiday fires, a wreath decorated in red lights is displayed on the West side of the City Hall at 100 W. Woodstock Street in the Fire Department Watch Office window. In the unfortunate event of a holiday related fire, a red bulb will be replaced with a white bulb. The program will run through New Year's Day.



December is the peak time of year for home candle fires. Eleven percent of home candle fires occur during the holiday season compared to four percent the rest of the year.

One of every three home Christmas tree fires are caused by electrical problems.

A heat source too close to the tree causes roughly one in every four of the fires.

Crystal Lake Fire Rescue Department would like to offer these safety tips:

- Check your smoke alarm to make sure it is in good working order. Test your smoke alarm monthly and replace batteries every six months.
- Do not place candles or fragrance burners near drapes or other decorations.
- Choose a tree with fresh, green needles that do not fall off when touched.
- Water your fresh cut Christmas tree daily to keep it from drying out. A dry tree becomes extremely flammable. Use caution with decorative lights.
- Never leave home with your decorations still lit and don't overload your tree with too many lights.
- Replace frayed or cracked light strands with Underwriters Laboratory (UL) approved devices. Keep pets and children away from electrical cords.
- Clean your fireplace yearly. Don't hang flammable decorations by your fireplace. The stockings might look cute hanging over your fireplace, but they are a fire hazard.
- Do not overload wall plugs or extension cords. If electric cords or decorations are to be used outdoors make certain that they are designed for that use. Do not place electric cords under rugs or carpets. All electric cords should be UL approved.

After the Holidays:

Dispose of your tree after the holidays or when it is dry. Dried out trees are a fire danger and should not be left in your home or garage.

CITY OF CRYSTAL LAKE WINTER SEASON PREPARATIONS

It's that time of year again when the hot, humid summer days turn into long, cold winter nights. Luckily, the past two winters have been relatively mild for the Midwest. Last winter, the Public Works Department responded to 34 snow and ice events that produced a cumulative 25" of snowfall in Crystal Lake. While the 2016/2017 winter season was milder than expected, the Public Works Department has begun preparing for the 2017/2018 winter season. In the weeks and months before the winter weather sets in, Public Works staff completes snowplow truck inspections, and all trucks are converted into "winter mode" with the installation of de-icing equipment, pre-wetting tanks, and snowplows. All of the City's snowplow drivers review their routes and familiarize themselves with new equipment or procedures.



As we enter into the winter season here are a few helpful reminders and tips:

- · Arterial streets are plowed first since all side streets funnel into these heavier used roads
- · Secondary streets, such as residential and local streets, will be plowed next
- Residential streets will be plowed in about 2.5 to 3 hours; center-lined and plowed down both sides
- When shoveling your driveways, snow should be placed to the left of the driveway (to the left if facing the driveway) as this helps our plow drivers push the snow in the appropriate areas
- Once plow drivers have plowed your road, and if you still need to snow blow your driveway, it is best to place the snow in your yard or in the parkway to prevent snow piles from building up at the end of your driveway
- Snow should be cleared from fire hydrants to assist the Fire/Rescue Department
- Residents are asked not to park on City streets at night. Parking is prohibited from 2:00 a.m. to 6:00 a.m.

HOLIDAY LIGHTS RECYCLING PROGRAM

The City of Crystal Lake, in partnership with Elgin Recycling, is accepting holiday lights for recycling December 1, 2017 through February 23, 2018.

Residents can drop-off their unwanted holiday lights at City Hall, located at 100 W. Woodstock Street, Monday through Friday between the hours of 8:00 a.m. and 5:00 p.m. Drop-off bins are located in the City Hall lobby next to the Finance/Administration counter.

All colors and lengths of holiday string lighting, including mini-lights, C7 lights, C9 lights, rope lights, LED lights, extension cords are accepted. Garland, live greens, wreaths or other non-recyclables are not accepted.

MDC Environmental Services, the City's refuse contractor, will conduct Christmas tree recycling from Monday, January 1 though Friday January 12, 2018.

Residents should have their Christmas tree on the curbside by 7:00 a.m. between Monday, January 1 though Friday January 12, 2018 to be collected for composting. Trees will be collected throughout this time period, however it is a special collection and may not occur on the same day as residents' scheduled collection day.


