

Crystal Lake Receives AAA Bond Rating

The City of Crystal Lake is proud to announce that Standard & Poor's (S&P) Global Ratings has raised the long-term rating on the City of Crystal Lake to AAA, with a stable outlook.

The City of Crystal Lake's AAA credit rating represents the highest credit rating that can be earned by an organization and has been assigned to very few governments within the State of Illinois. According to S&P, the City of Crystal Lake "embodies many characteristics of a 'AAA' issuer, including a diverse economy that is independently strong and growing... with consistently stable financial operating results with no discernible budgetary pressures... and a sophisticated and knowledgeable management team that has strong planning practices. Furthermore, the debt burden is very low." Other strong credit qualities noted include:

- A growing economy with an economic score anticipated to improve to very strong
- Maintenance of very strong reserves and liquidity
- Very strong management conditions, with robust planning and policies
- Very low debt profile, with manageable pension costs

The City has worked diligently to balance delivery of consistently high quality services while prudently building sustainable reserves of funds to assist in times of economic downturn or unexpected disastrous events. The AAA rating is a testament to the commitment of the City Council and the City's leadership team to financial policies and strategy, which preserve a long-term sustainable financial plan for the City.

The rating applies to both existing General Obligation (GO) debt and to the City's planned Series 2022 GO Bonds. The City is issuing these bonds to fund water and sewer capital projects, including potable water, sanitary sewer and storm sewer improvements. Rating agencies such as S&P issue credit ratings to assist investors in choosing the right investments for their portfolios, as they provide insight to potential bondholders of the City's ability to repay the funds. The AAA rating will allow the City to borrow funds at the best possible rate, minimizing interest cost and freeing up other City funds for necessary projects.

Updates to Burn Ordinance

On April 22, 2022, the Crystal Lake City Council approved an amendment to the City's burn ordinance. With this change, a physical burn permit is no longer required for recreational burning. There are no other changes to the burn ordinance.

Burn Ordinance Requirements:

- Fuel for recreational fires must consist ONLY of dry and seasoned firewood, ignited with a small amount of paper.
- Accelerants cannot be used to ignite firewood.
- The use of fire for disposing of waste, such as trash, yard waste, or construction materials is prohibited.
- Recreational fires must be no more than three feet in diameter. Pile size is limited to two feet in height.
- Recreational fires cannot burn longer than three hours and must be completely extinguished by midnight.
- A responsible individual over 17 years of age must monitor the fire at all times, until extinguished.
- Recreational fire pits are required to be at least 15 feet from any structure (Shed, deck, fence, swing set, etc.).
- The Crystal Lake Fire Rescue Department or its designated enforcement representatives prohibit recreational burning when burning is offensive, objectionable, or creates a nuisance due to smoke or odor emissions and when atmospheric conditions or local circumstances make such fires hazardous to life or property.
- If the Crystal Lake Fire Rescue Department is dispatched to a recreational fire not abiding by the ordinance, the fire will be extinguished.
- Any person violating the burn ordinance may be, upon conviction, fined according to the provisions of Chapter I, Article II, General Penalty for each offense. Every day's failure to comply with such provision may constitute a separate violation.

Grill Safety

There's nothing like the smell of grilling in the summertime. However, we often forget the damage a grill can do if we are not cautious. Below are some tips to remember when grilling to make sure you and your family are safe this summer.

- Remember to only use propane and charcoal grills outdoors.
- Keep grills away from your home, railings, balconies, and low-hanging branches.
- Keep children and pets at least three feet from the grilling area.
- Remove grease and fat buildup from the grill and trays below the grill.
- Never leave a hot grill unattended.
- Never light a gas grill while the lid is closed.
- Keep any charcoal fluid away from children and heat sources.
- When you finish cooking, allow coals and grill to cool completely or turn off propane.

Keep a **3-foot safe zone** around your grill to keep kids and pets safe.

Marina

Swim Beach

The Swim Beach is open daily from 10:00 a.m. to 7:30 p.m., weather permitting.

General Rules

- Swimming is only allowed within the beach area, and a lifeguard must be present. Swimming outside the buoyed beach area or when no lifeguard is present is strictly prohibited.
- The use of flotation devices such as rafts, noodles, lounges, water wings, etc., is not permitted. Only life jackets approved by the Coast Guard are allowed. Life jackets are available at the Lake House Complex for no additional charge.
- Young Crystal Lake residents will be required to show a valid school ID to receive free admission when a parent/legal guardian is not present.

A VISIT TO MUNSHAWVILLE


Who's been to Munshawville? Chances are, most of us have been there – we just didn't know it! Munshawville was never an incorporated village or town, rather it was a community of people whose common bond was their location. Although there are no firm boundaries of Munshawville, this farming and dairying community centered around today's Three Oaks Road and Lutter Drive. The principal landowners were William and John Munshaw.

William and John Munshaw were both born in Thornhill, Ontario, Canada. Together with their wives and growing families, the brothers settled in Algonquin Township in 1869, purchasing adjoining farmland from local landowner, Hosea B. Throop. William called his farm, "Thornhill". While John kept a lower profile, William Munshaw, his wife Maria and their seven children were much more active in the community.

Prior to the arrival of the Munshaw brothers, Hosea B. Throop sold a small tract of land for \$20 to the Board of Trustees of Common Schools in Algonquin Township. A brick one-room schoolhouse was built and was first known simply as School District #49. Recollections recorded by early students indicate the boys and girls sat separately in the room, with as many as 40 students in the room. Beginning in the early 1870s, the area and school were commonly referred to as "Munshawville".

The school was the nucleus for Munshawville. Not only did it educate the children, it provided space for music lessons, adult education, civic discussions and debates, social gatherings and even church services.

As with most communities, sometimes there were squabbles among neighbors. In 1872, Sarah Cox, who lived east of William Munshaw, discovered 65 of her sheep had been killed. Sarah wasn't about to sit back and be quiet! She accused William Munshaw's dog of being the slaughterer and was just about to proceed with legal proceedings to recover the value of the sheep when it was discovered that the sheep-eaters were actually hogs belonging to Mrs. Cox! It is presumed a sheepish Sarah Cox apologized and all was well in Munshawville again.

William and Maria Munshaw had four daughters and three sons. One daughter, Emma married Fred Goodwin. Emma & Fred's son Dwight was a well-known musician in Crystal Lake. The Munshaw's son, John served on the Algonquin Village Board and was a member of the Algonquin Fire Department. Their son Lambert "Bert" worked for many years at the American Terra Cotta Co. And son William remained on the farm, retaining ownership of "Thornhill" until his death in 1930.

The Munshawville School closed its doors in 1947. By then, the Munshaw family was scattered about, and the little community of Munshawville became just a memory.

- December 16, 2022: Yard waste collection ends.


Quarry Cable Park
