Item: North Elementary School Area Traffic Control Changes

the north side of Woodstock Street from the intersection of Woodstock and Oak Streets to a point 580 feet west of the

centerline of Oak Street.

#### Background:

The Traffic Safety Committee has been working with District 47 to develop ways to mitigate congestion along Woodstock Street during the morning drop-off and afternoon pick-up times for North Elementary School. The current drop-off/pick-up procedure is for vehicles to queue along the north side of Woodstock Street in the on-street parking area and in the school parking lot with children exiting/entering the vehicles at the north end of the parking lot, see attached exhibit.

In October of 2014, the City Council approved parking restrictions and turning restrictions that have improved traffic flow in the area; however, there is still one area that is impacted by drop-off/pick-up traffic. The portion of Woodstock Street in front of Park Place is narrower than the rest of Woodstock Street to the west. City and School District staff observed that cars queue in this area during afternoon pick-up to either park or to wait for their child to come out to them.

Since this section of Woodstock Street is narrower, the queued cars contribute to additional congestion and impede the flow of traffic. By restricting parking in this area, traffic flow will improve and allow cars to move in and out of the area quickly. Staff contacted the Crystal Lake Park District as they own Park Place and they are in support of this proposed restriction. The School District is also supportive of these restrictions and a letter of support for this change is attached from District 47.

#### **ORDINANCE**

SECTION III: That any person, firm, or corporation violating any provision of this Ordinance shall be fined in accordance with Chapter 1, Article II providing for General Penalty Provision in the Code of Ordinances of the City of Crystal Lake, Illinois.

SECTION IV: That this Ordinance shall be in full force and effect from and after its passage and approval as provided by law.

SECTION V: All ordinances and parts of ordinances in conflict herewith are hereby repealed.

#### **Background:**

The City has received a request from Coffee House Holdings, Inc. d/b/a Starbucks for the Council to consider the adoption of an ordinance providing for an amendment to the liquor license restriction provisions of the City Code, increasing the number of Class "14" liquor licenses from the current 4 licenses to 6 licenses. Coffee House Holdings, Inc. has requested a liquor license for two Starbucks locations in Crystal Lake, 40 North Williams St. #A and 6000 Northwest Highway, Suite 13J. The applicant is requesting a Class 14 license for both locations. Liquor will only be allowed in the interior of the café for both locations.

Section 329-5(N) of the City Code permits the issuance of a Class "14" liquor license which shall authorize the retail sale of beer and wine for consumption only on the premises specified in the license where sold between the hours of 11:00 a.m. and 1:00a.m. Monday, Tuesday, Wednesday, Thursday; the hours of 11:00 a.m. and 2:00 a.m. Friday and Saturday; and between the hours of noon on Sunday and 1:00 a.m. on Monday. A Class A type restaurant may be located on the premises.

The applicant does not currently hold a liquor license with the City of Crystal Lake and a fingerprint/background search by the Illinois State Police and FBI is currently pending. The issuance of the licenses would be contingent on the applicant passing the background check. The Chamber of Commerce has agreed to act as the Registered Agent for both locations.

Other current holders of a Class "14" liquor license are: Chuck E. Cheese, New Peking Restaurant, Noodle's & Company and Portillo's.

### **Background:**

The City has received a request from Lake Ventures, LLC, a Delaware limited liability company, d/b/a Fresh Thyme Farmers Market, LLC for the Council to consider the adoption of an ordinance providing for an amendment to the liquor license restriction provisions of the City Code, increasing the number of Class "13" liquor licenses from the current 21 licenses to 22 licenses. Fresh Thyme will be located in the old Dominick's building at 5340 Northwest Highway, Suite B. Construction on the store is ongoing and it anticipates opening to the public in the late fall of 2015.

Section 329-5-M of the City Code permits the issuance of a Class "13" liquor license which shall authorize the sale of alcoholic liquors on the premises specified in the license in packages only but not for consumption on the premises where sold between the hours of 7:00 a.m. and 1:00 a.m. Monday, Tuesday, Wednesday, Thursday, and Friday, the hours of 7:00 a.m. Saturday and 2:00 a.m. Sunday, and the hours of 7:00 a.m. Sunday and 2:00 a.m. Monday. A Class B Type restaurant may be located on the premises.

The applicant does not currently hold a liquor license with the City of Crystal Lake and a fingerprint/background search by the Illinois State Police and FBI is currently pending. The issuance of the licenses would be contingent on the issuance of the Certificate of Occupancy, the applicant passing the background check, submitting liquor liability insurance and a bond naming the City as additionally insured. The applicant is working with the Chamber of Commerce to act as their Registered Agent.

Other current holders of a Class "13" liquor licenses are: 7-Eleven (Terra Cotta), Cardinal Wine & Liquors, Midwest Petroleum Dev., Convenient Food Mart, Cost Plus World Market, Crystal

Lake Food & Liquor, CVS Pharmacy, Fresh Market, General Store, Joseph's Marketplace, LaRosita of Mesos Group, Inc., Oak Street Food & Liquor, Open Pantry/Shell #801, Osco Drug, Sam's Club, Target, Teddy's Liquors, Walgreens (Northwest Highway), Walgreens (Route 31) and Wal-Mart. A license for Bucky's Express was approved but not yet issued.

**Item:** 2016 and 2017 Independence Day Fireworks

Displays

**Council Discretion:** A motion adopting a resolution authorizing the City

Manager to execute a contract renewal with Pyrotecnico for the 2016 and 2017 Independence Day Fireworks Displays in the annual amount of \$25,000 and authorizing the City Manager to approve up to 10 percent in justifiable contract

amendments from a contingency allowance.

#### **Background:**

At the March 3, 2009 City Council meeting, the City Council awarded the proposal for the Independence Day Fireworks Display and adopted a resolution authorizing the City Manager to execute an agreement with the lowest responsible and responsive proposer, Pyrotecnico, for the Independence Day Fireworks Display in the amount of \$25,000 per year. The initial contract period was for one (1) year. The proposal included provisions for renewal, if mutually agreed upon by both parties.

Since initially awarding the contract to Pyrotecnico, the City has received positive feedback from residents regarding the fireworks display, including this most recent display. City staff has experienced no issues with the staff of Pyrotecnico. In addition, Pyrotecnico has agreed to not increase prices for 2016 and 2017.

Since initially awarding the contract to Pyrotecnico, the City has been able to maximize the fireworks display by conducting the display either before or after the prime fireworks display day of July 4th. By not conducting the display on the 4th of July, the City is able to receive the same show for less money. In addition, traditionally, the Independence Day Parade is held on the same day as the fireworks display. Since the parade is not conducted on July 4th, parade organizers are able to schedule groups that would not be available for the Crystal Lake parade if it were held on July 4th.

City staff sought comments from the Crystal Lake Park District, the Crystal Lake Chamber of Commerce and the organizers of the Lakeside Festival. All agreed that the best time to display the fireworks would be **Sunday**, **July 3**, **2016** and **Sunday**, **July 2**, **2017**. Both days would be the last day of the Lakeside Festival and the date of the Crystal Lake 4<sup>th</sup> of July parade.

The rain date for the 2016 display will be Sunday, July 10, 2016 and the rain date for the 2017 display will be Sunday, July 9, 2017. The City Attorney has reviewed this matter.

Item: Contractual Agreement between the Crystal Lake Police

Department and the Illinois Department of Revenue.

**Staff Recommendation:** Motion to adopt a resolution authorizing the City Manager to

execute a Contractual Agreement with the Illinois Department of Revenue enabling the Crystal Lake Police Department to participate in the FY 2016 Tobacco Enforcement Program.

#### **Background:**

The Illinois Department of Revenue administers the Illinois Liquor Control Commission, which is responsible for liquor and tobacco compliance. The Commission oversees the following activities: Statewide liquor inspections, reviewing and renewing liquor license applications, legal interpretations for related liquor matters, liquor industry education, the Under 21 program, and the BASSET Program, which trains liquor servers how to serve responsibly. In addition, the Illinois Liquor Control Commission oversees the State's tobacco enforcement activities.

The Police Department submitted a grant funding request through the Illinois Department of Revenue and was awarded \$4,620 to conduct a Tobacco Enforcement Program. During the past several years, the Police Department has partnered with the Illinois Liquor Control Commission to coordinate these tobacco enforcement activities. The Commission provides grant appropriations for the education of tobacco retailers, as well as for enforcement programs. One such program is the "Kids Can't Buy 'Em Here" Campaign. Through this campaign, the Police Department is able to assist retailers with conformity strategies and initiate activities that promote awareness of compliance with minimum-age tobacco laws. This grant also provides our community with educational retail kits. The Police Department distributes these kits, which includes information on State tobacco laws, required signage, training guides for retail staff, and educational posters. Finally, the grant requires the Police Department's participation in three compliance checks during the current fiscal year.

The Police Department is seeking to continue this partnership with the Department of Revenue as well as resume our tobacco education and enforcement activities in the community. These appropriations would provide the Police Department with the appropriate resources to ensure tobacco compliance at retail stores.

#### Background:

The Fire Rescue Department received approval in the FY 2015-2016 Fire Rescue Budget for a replacement heavy-duty fire apparatus pumper. Engine 340 is due next for replacement in the schedule. Engine 340 is a 1998 Emergency One pumper with over 100,500 miles and 9,976 hours.

On Friday, December 19, 2014, the City of Crystal Lake publicly opened and read aloud the bids received for one (1) Heavy Duty Fire Apparatus Pumper. Only two vendors submitted proposals. To ensure competitive pricing and the ability to review additional potential vendors, the Fire Rescue Department investigated the Houston-Galveston Area Council (HGAC) purchasing cooperative.

Fire Rescue staff contacted several heavy duty pumper vendors through the HGAC and presented them with our pumper specification. Each vendor provided staff with their brand's pumper that most closely matched our specification. After reviewing each of the proposals with the City's Fleet Services, and weighing all the proposals received including the original proposals solicited in December 2014, it was determined that the proposal for the 2015 Spartan ERV Star Series Fire Apparatus Pumper submitted by Equipment Management Company (EMC), Inc., through the closed bid process in December 2014, best met the needs of the Fire Rescue Department.

#### **Background:**

The Public Works Department requested approval for fleet vehicle replacement as part of the Fiscal Year 2015-2016 Budget. Three new 2016 Ford F-250 pickups will replace three Ford Pickups. The replaced vehicles are a 2000, 2001, and 2004 Ford F250s with heavy corrosion. These vehicles will be primarily used by our Water and Wastewater Divisions for day-to-day operational needs such as site checks and hauling items. In addition, these vehicles will be used during the plowing season.

As members of the State of Illinois Joint Purchase Program, the City is able to take advantage of the cooperative members' leveraged contract. This program allows members to combine purchasing power, which enables significant cost reductions. All items that are bid through the cooperative follow the same public procurement statutes that the City follows during the competitive, sealed bidding process.

Previously on Friday, June 19, 2015, the City opened bids for polymer for solids handling. This bid resulted in only one submission. Since the City prefers multiple, competitive bids, this item was re-bid.

Both bids sought for the provision of emulsified polymers for the following uses: Centrifuge for anaerobic sludge dewatering, Gravity Belt Thickener operations for Waste Activated Sludge, and for coagulation of the aluminum sulfate used for Phosphorus removal (Anionic). Polydyne Clarifloc-C-9530 and Anionic – A228 are the polymers currently being used by the City.

#### Recommendation:

The Public Works Department has reviewed all bids received for completeness and accuracy. For the past several years, the Public Works Department has utilized Polydyne, Inc., and is satisfied with this manufacturer's product. It is staff's recommendation to award the contract to the lowest responsible and responsive bidder, Polydyne, Inc. for the 2016 contract period with two optional one-year extensions.

Consultant Selection Approval for Engineering Services for

Lift Station #9 Improvements.

**Staff Recommendation:** 

Motion to award the proposal for engineering services for Lift Station #9 improvements to the most responsible and responsive proposer, Crawford, Murphy, & Tilly, Inc., and adopt a resolution authorizing the City Manager to execute an agreement with Crawford, Murphy, & Tilly, Inc. (CMT) in the amount of \$43,481.00, allowing for a 10 percent

contingency.

#### **Background:**

Lift Station #9 is one of the older lift stations and is located at 493 Pine Street. Staff has had ongoing operation and maintenance issues with this station. In January 2015, the City had authorized a condition assessment of the lift station by Donohue & Associates, Inc. The assessment evaluated all aspects of the lift station and the following are the highlights of the assessment:

- The existing forcemain is in very poor condition and is choked down in size due to tuberculation. Tuberculation is the development of small mounds of corrosion products on the inside of pipes.
- The existing arrangement of the wet well and discharge piping has promoted premature aging, requires wet well entry regularly, and is difficult to provide routine maintenance.
- There are no flow or pressure monitors which makes operational control and performance monitoring difficult.
- There is no onsite backup generator for power outages and requires staff to bring a portable generator in the event of a power outage.

The tributary area to this lift station consists of an area described roughly as Route 14 – Dole Avenue – Oak Street – Rockland Road. The area has had infiltration and inflow challenges despite smoke testing, and an aggressive grouting and lining program. This work has helped but

the actual operation of the lift station is still compromised by the condition of the station and forcemain. Further, there is a history of surface flooding in the Pine Street and Oriole Trail area further exacerbating the problems.

In order to address these ongoing problems, the City budgeted for and issued an RFP for the Engineering Services to design the necessary improvements and perform the construction services. Proposals with base scope services provided were received as follows:

Optional tasks recommended for the proposal with CMT include:

1.) Geotechnical investigation	\$5,260

#### Consultant Selection Process

The Public Works Department followed the City's Purchasing Policy to secure a qualified engineering firm to address this project. The City received proposals from five firms in response to the request.

Staff from the Public Works Department reviewed the proposals and ranked the firms based on their qualifications. The qualifications criteria that were considered during the review were:

- 1. Proposal completeness
- 2. Firm's reputation and integrity
- 3. General experience and history of performance on similar projects
- 4. Current or past projects related to the scope of services
- 5. Understanding of the project
- 6. Adherence to the Project Scoping Summary
- 7. Experience of personnel
- 8. Interview

#### **Discussion:**

The Public Works Department identified Crawford, Murphy, & Tilly, Inc. (CMT) as being the most responsive and responsible proposer for reasons including:

- Proposal adequately addressed the aspects of this project;
- Proposal identified past projects of a similar scope to the Crystal Lake project;
- Proposal provided the City with a feasible schedule; and
- The firm has had several previous projects with the City with favorable results.

CMT's approach integrates the full spectrum of their organization and the experience they have related to pumping stations. They allocated a sufficient amount of hours with an experienced team.

Once CMT completes the engineering design services portion of the project, City staff will begin preparing for the next phase of this project, implementation of design. To help fund this endeavor, City staff will submit an application for Community Development Block Grant Funding (CDBG) if available. In addition, previous CDBG funding announcements have sought applications that included infrastructure, housing and public service projects, which again, this project would qualify. In 2015, applications were accepted during January and February, so if funding is available again, staff will submit an application during this timeframe.

#### **Recommendation:**

Based upon a qualifications review to the RFP requirements and associated costs, staff's recommendation is to select CMT to perform the engineering design and construction services. The City would also recommend that the environmental testing, geotechnical investigation, and Inflow/Infiltration analysis be selected as optional tasks and included in the contract for \$12,250 to fully evaluate the area around the lift station and forcemain.

Funds have been budgeted for this work.
