### Liquor License Classifications

#### Class 1

- Retail sale of alcoholic liquor for consumption on the premises (interior of the building).
- Retail sale of alcoholic liquor in the original package.
- Retail sale of alcoholic liquor in the original package by the license holder at wine-tasting events that are held within the City.
- Class A type restaurant (a restaurant where ninety-five percent of the product that is sold will be consumed within the confines of the restaurant) may be located on the premises.

Monday – Thursday	11:00 a.m. to 1:00 a.m.
Friday and Saturday	11:00 a.m. to 2:00 a.m.
Sunday	Noon to 1:00 a.m.

**Annual Fee:** \$1,350.00

#### Class 2

- Retail sale of alcoholic liquor for consumption on the premises (interior of the building).
- A Class A type restaurant (a restaurant where ninety-five percent of the product that is sold will be consumed within the confines of the restaurant) may be located on the premises.

Monday – Thursday	11:00 a.m. to 1:00 a.m.
Friday and Saturday	11:00 a.m. to 2:00 a.m.
Sunday	Noon to 1:00 a.m.

**Annual Fee:** \$1,150.00

#### Class 3

- Retail sale of alcoholic liquor for consumption on the premises (interior of the building).
- Retail sale of alcoholic liquor in the original package.
- A Class A type restaurant (a restaurant where ninety-five percent of the product that is sold will be consumed within the confines of the restaurant) may be located on the premises.

Monday – Thursday	11:00 a.m. to 1:00 a.m.
Friday and Saturday	11:00 a.m. to 2:00 a.m.
Sunday	10:00 a.m. to 1:00 a.m.

**Annual Fee:** \$1,475.00

**Class 4**

- Retail sale of alcoholic liquor for consumption on the premises (interior of the building).
- A Class A type restaurant (a restaurant where ninety-five percent of the product that is sold will be consumed within the confines of the restaurant) may be located on the premises.

Monday – Thursday	11:00 a.m. to 1:00 a.m.
Friday and Saturday	11:00 a.m. to 2:00 a.m.
Sunday	10:00 to 1:00 a.m.

**Annual Fee:** \$1,750.00

**Class 5**

- Retail sale of alcoholic liquor for consumption on the premises (interior of the building).
- Retail sale of alcoholic liquor in the original package.
- A Class A type restaurant (a restaurant where ninety-five percent of the product that is sold will be consumed within the confines of the restaurant) may be located on the premises.

**Hours:**

Monday – Thursday	11:00 a.m. to 1:00 a.m.
Friday and Saturday	11:00 a.m. to 2:00 a.m.
Sunday	10:00 a.m. to 1:00 a.m.

**Annual Fee:** \$1,950.00

---

**Class 7**

- Retail sale of alcoholic liquor for consumption on the premises, both the interior of the building and an open unroofed area immediately contiguous to the building or structure.
- Retail sale of alcoholic liquor in the original package.
- A Class A type restaurant (a restaurant where ninety-five percent of the product that is sold will be consumed within the confines of the restaurant) may be located on the premises.

**Hours:**

Monday – Thursday	11:00 a.m. to 1:00 a.m.
Friday and Saturday	11:00 a.m. to 2:00 a.m.
Sunday	Noon to 1:00 a.m.

**Annual Fee:** \$1,700.00

City of Crystal Lake-Liquor License Classifications

**Class 8**

- Retail sale of alcoholic liquor for consumption on the premises, including not only the interior of the building but also an open unroofed area immediately contiguous to the building or structure where alcoholic beverages are served or consumed.
- A Class A type restaurant (a restaurant where ninety-five percent of the product that is sold will be consumed within the confines of the restaurant) may be located on the premises.

**Hours:**

Monday – Thursday	11:00 a.m. to 1:00 a.m.
Friday and Saturday	11:00 a.m. to 2:00 a.m.
Sunday	10:00 a.m. to 1:00 a.m.

**Annual Fee:** \$1,500.00

---

**Class 9**

- Retail sale of alcoholic liquor for consumption on the premises, both the interior of the building and an open unroofed area immediately contiguous to the building or structure.
- Retail sale of alcoholic liquor in the original package.
- A Class A type restaurant (a restaurant where ninety-five percent of the product that is sold will be consumed within the confines of the restaurant) may be located on the premises.

**Hours:**

Monday – Thursday	11:00 a.m. to 1:00 a.m.
Friday and Saturday	11:00 a.m. to 2:00 a.m.
Sunday	10:00 a.m. to 1:00 a.m.

**Annual Fee:** \$1,825.00

---

**Class 10**

- Retail sale of alcoholic liquor for consumption on the premises, both the interior of the building and an open unroofed area immediately contiguous to the building or structure.
- A Class A type restaurant (a restaurant where ninety-five percent of the product that is sold will be consumed within the confines of the restaurant) may be located on the premises.

**Hours:**

Monday – Thursday	11:00 a.m. to 1:00 a.m.
Friday and Saturday	11:00 a.m. to 2:00 a.m.
Sunday	10:00 a.m. to 1:00 a.m.

**Annual Fee:** \$1,625.00

---

## City of Crystal Lake-Liquor License Classifications

### **Class 11**

- License issued to a regularly organized club established for at least ten years prior to application for license.
- Retail sale of alcoholic liquor for consumption only in the club quarters.
- Club must be organized for purpose or object other than sale or consumption of alcoholic liquor.

#### **Hours:**

Monday – Thursday	11:00 a.m. to 1:00 a.m.
Friday and Saturday	11:00 a.m. to 2:00 a.m.
Sunday	Noon to 1:00 a.m.

**Annual Fee:** \$800.00

---

### **Class 12**

- License issued to a special occasion facility organized for purposes of providing banquets, wedding and other receptions, meetings, parties or other special events upon contractual engagement.
- Retail sale of alcoholic liquor for consumption only on the premises.
- The special occasion facility may not be open to the general public and must be limited to the contracting party and his/her invited guests.

#### **Hours:**

No Class 12 License shall be issued until the Local Liquor Control Commission and the Mayor and City Council have established the hours for operation of the Class 12 license. No Class 12 license shall be open for business except during the hours established by this Chapter, provided, however, that the Mayor and City Council may in their discretion extend said hours upon request.

**Annual Fee:** \$750.00

---

### **Class 13**

- Sale of alcoholic liquor on premises in packages only but not for consumption on premises where sold.
- A Class B type restaurant (a restaurant facility where the product is served in cafeteria-line style in disposable containers which product could be taken out or eaten at tables or counters; no table service provided by employees of the restaurant) for consumption only on the premises specified in the license where sold.

#### **Hours:**

Monday – Friday	7:00 a.m. – 1:00 a.m.
Saturday and Sunday	7:00 a.m. – 2:00 a.m.

**Annual Fee:** \$625.00

City of Crystal Lake-Liquor License Classifications

**Class 14**

- Retail sale of **beer and wine** for consumption only on the premises.
- A Class A type restaurant (a restaurant where ninety-five percent of the product that is sold will be consumed within the confines of the restaurant) may be located on the premises.

**Hours:**

Monday – Thursday	11:00 a.m. – 1:00 a.m.
Friday and Saturday	11:00 a.m. – 2:00 a.m.
Sunday	Noon – 1:00 a.m.

**Annual Fee:** \$1,000.00

---

**Class 15**

- Retail sale of **beer and wine** in packages only but not for consumption on the premises where sold.
- A Class B type restaurant (a restaurant facility where the product is served in cafeteria-line style in disposable containers, which product could be taken out or eaten at tables or counters, with no table service provided by employees of the restaurant) may be located on the premises.
- Food for consumption on the premises or which can be taken out shall not be sold by any Class 15 License holder.

**Hours:**

Monday – Friday	7:00 a.m. – 1:00 a.m.
Saturday and Sunday	7:00 a.m. – 2:00 a.m.

**Annual Fee:** \$500.00

---

**Class 16**

- **Temporary Liquor License**
- License issued to not-for-profit corporation.
- Retail sale of beer and wine for consumption upon the premises.
- The license shall be for a period not to exceed three (3) days.
- Issued only for special events sponsored by the not-for-profit corporation requesting the license.

**Hours:**

Approved by Liquor Commissioner and City Council.

**Temporary Liquor License Fee:** \$20.00 (per 3 day period)

## City of Crystal Lake-Liquor License Classifications

### **Class 17**

- Issued to a congregate care facility within an independent congregate living complex within a private retirement community.
- Retail sale for consumption only on the premises specified.
- A separate license shall be issued for each phase of the congregate living complex.

#### **Hours:**

No Class 17 License shall be open for business except during the hours established by this chapter, provided, however, that the Mayor and City Council may in their discretion extend said hours upon request.

**Annual Fee:** \$1,850.00

---

### **Class 18**

- Issued to a sports facility.
- Sale and consumption of alcoholic liquor on the premises.
- Retail sale of alcoholic liquor in the original package.
- A Class A type restaurant (a restaurant where ninety-five percent of the product that is sold will be consumed within the confines of the restaurant) or a Class B type restaurant (a restaurant facility where the product is served in cafeteria-line style in disposable containers, which product could be taken out or eaten at tables or counters, with no table service provided by employees of the restaurant) may be located on the premises.

#### **Hours:**

The Mayor and City Council shall establish the closing for each portion of the sports facility for which a Class 18 License is issued. In taking into account the establishment of the closing hours, the Mayor and City Council will consider those times during which minors will be present in each portion of the sports facility covered by the Class 18 license.

**Annual Fee:** \$1,250.00

---

### **Class 19**

- **Temporary Liquor License**
- Issued to not-for-profit corporation, including municipal corporations.
- Retail sale of beer, wine and alcoholic liquor drinks for consumption upon the premises
- License for a period not to exceed three days and issued only for special events sponsored by the not-for-profit corporation requesting the license.

#### **Hours:**

Liquor Commission and City Council establish hours of operation.

**Temporary Liquor License Fee:** \$20.00 (per three day period)

---

## City of Crystal Lake-Liquor License Classifications

### **Class 20**

- **Temporary Liquor License**
- Issued to a not-for-profit corporation or organization
- Retail sale of beer on the premises in packages only
- No consumption on premises.
- License period – 3 days
- Issued only for special events sponsored by the not-for-profit corporation or organization requesting the license.

#### **Hours:**

Hours of operation established by Liquor Commissioner and City Council.

**Temporary Liquor License Fee:** \$20.00 (per 3 day period)

---

### **Class 21**

- Issued to performing arts facilities
- Retail sale of alcoholic liquor for consumption before and during performances or events in the Centers owned by municipal corporations or governmental agencies of the State of Illinois and designated for use by the performing arts at which time the facilities are open to the general public and at such other times as the Mayor and City Council shall approve.

#### **Hours:**

Before and during performances or events in the Centers owned by municipal corporations or governmental agencies of the State of Illinois and designated for use by the performing arts at which time the facilities are open to the general public and at such other times as the Mayor and City Council shall approve.

**Annual Fee:** \$800.00

## City of Crystal Lake-Liquor License Classifications

### **Class 22**

- Retail sale of alcoholic liquor for consumption on the premises, both the interior of the building and an open unroofed area immediately contiguous to the building or structure.
- Retail sale of alcoholic liquor in the original package.
- Retail sale and consumption of alcoholic liquor within a tent erected adjacent to the premises specified permitted two times during any calendar year.
- A Class A type restaurant (a restaurant where ninety-five percent of the product that is sold will be consumed within the confines of the restaurant) may be located on the premises.

#### **Hours:**

Monday – Thursday	11:00 a.m. to 1:00 a.m.
Friday and Saturday	11:00 a.m. to 2:00 a.m.
Sunday	12:00 p.m. to 1:00 a.m.

The Mayor and City Council may authorize the license holder to be open at 10:00 a.m. on Sunday upon the license holder submitting a list of the dates that it requests the earlier Sunday opening hours to the Mayor and City Council for approval.

**Annual Fee:** \$1,825.00

---

### **Class 23**

- Sale of alcoholic liquor on premises in packages only but not for consumption on premises where sold.
- A Class B type restaurant (a restaurant facility where the product is served in cafeteria-line style in disposable containers which product could be taken out or eaten at tables or counters; no table service provided by employees of the restaurant) for consumption only on the premises specified in the license where sold.

#### **Hours:**

Sunday-Thursday	7:00 a.m. – 10:00 p.m.
Friday and Saturday	7:00 a.m. – 11:00 p.m.

**Annual Fee:** \$625.00

---

### **Class 24**

- Retail sale of alcoholic liquor for consumption on the premises, both the interior of the building and an open unroofed area immediately contiguous to the building or structure.
- A Class A type restaurant (a restaurant where ninety-five percent of the product that is sold will be consumed within the confines of the restaurant) may be located on the premises.

#### **Hours:**

Sunday - Saturday	7:00 a.m. to 12:00 a.m.

**Annual Fee:** \$1,950.00

## City of Crystal Lake-Liquor License Classifications

### **Class 25**

- Retail sale, on the premises specified, of alcoholic liquor, for consumption, on the premises.
- Retail sale of alcoholic liquor in the original package.
- A Class A type restaurant (a restaurant where ninety-five percent of the product that is sold will be consumed within the confines of the restaurant) may be located on the premises.

Monday-Thursday	7:00 a.m. - 1:00 a.m.
Friday and Saturday	7:00 a.m. - 2:00 a.m.
Sunday	7:00 a.m. - 1:00 a.m.

**Annual Fee:** \$1,350.00

---

### **Class 26**

- Retail sale of beer manufactured at such premises for consumption on the premises, both the interior of the building and an open unroofed area immediately contiguous to the building or structure.
- Retail sale, on the premises specified, of beer for consumption, on the premises.
- Retail sale on the premises of beer manufactured at such premises, in the original retail package.

#### **Hours:**

Monday-Thursday	11:00 a.m. - 1:00 a.m.
Friday and Saturday	11:00 a.m. - 2:00 a.m.
Sunday	12:00 noon - 1:00 a.m.

**Annual Fee:** \$1,150.00

---

### **Class 27**

- Catering Business - A business which provides food service and serves alcoholic liquor at locations not owned or leased by the catering business for consumption at such location.
- Catered Event - A dinner, banquet, party or other similar event at which food service and alcoholic liquor is provided for consumption on the premises by a Catering Business.
- Retail sale of alcoholic liquors in connection with the operation of an off-site catering business as defined herein, that provides and serves alcoholic liquor in connection with the catering of foods for Catered Events and for consumption only on the premises with the food of the Catered Event.

#### **Hours:**

Monday - Thursday	11:00 a.m. to 1:00 a.m.
Friday and Saturday	11:00 a.m. to 2:00 a.m.
Sunday	Noon to 1:00 a.m.

**Annual Fee:** \$900.00
