 - a. Gym Reimburstment Chair Rich Kreher. Chair Rich Kreher stated that he talked to our Attorney previously before the January 6, 2016 meeting. The Foreign Fire Insurance Board Attorney said he spoke with the city's attorney, and everything was alright and legal, except the child care portion. The city's attorney did not know there were stipulations to receiving a reimburstment check. The Foreign Fire Insurance Board Attorney explained all of the details. Chief Paul DeRaedt said he needed to talk to his attorney also. He suggested getting a written letter from the States Attorney to make sure this was legal. Chair Rich Kreher wanted to set aside funds til this issue was resolved. Chief DeRaedt said the Foreign Fire Insurance Board could be prosecuted by the States Attorney with a misdemeanor, potentially. If not the whole board, the Treasurer would be for writing and signing the checks. It was brought up that other cities allow the department to use their monies for gym reimburstment and have not had any issues.
