Background:

- A concrete slab existed on the property, which was used for a previous shed. Prior to 2013, accessory structures, like sheds, were permitted 3 feet from the side property line. The current code requires 5 feet from the side property line.
- The slab was in good condition, so the petitioner wanted to reuse it, requiring the variation.

Key Factors:

• Request: Construction of an accessory structure 3 feet from the side lot property line, a variation of 2 feet.

PZC Highlights:

The following discussion took place during the Planning and Zoning Commission hearing:

- The Planning and Zoning Commission (PZC) understood the rationale for the petitioner's request.
- The PZC found that the petition met the Findings of Fact.

The Planning and Zoning Commission recommended approval (7-0) of the petitioner's request.

AN ORDINANCE GRANTING A VARIATION AT 349 2nd COURT

WHEREAS, pursuant to the terms of the Application (File #2017-29) before the Crystal Lake Planning and Zoning Commission, the Applicant has requested the granting of a Simplified Residential Variation to allow the construction of a shed on an existing slab 3 feet from the side yard property line, a variation of 2 feet; and

WHEREAS, the Planning and Zoning Commission of the City of Crystal Lake, pursuant to notice duly published on September 30, 2017 in the Northwest Herald, held a public hearing at 7:30 p.m., on October 18, 2017 at City Hall at 100 W. Woodstock Street, Crystal Lake, Illinois to consider the proposed Simplified Residential Variation; and

WHEREAS, on November 1, 2017, the Planning and Zoning Commission, having fully heard and considered the testimony of all those present at the public hearing who wished to testify, made findings of fact as required by law and recommended to the Mayor and City Council of the City of Crystal Lake that the proposed Simplified Residential Variation be approved, all as more specifically set forth in that certain Report of the Planning and Zoning Commission in Case #2017-29, dated as of November 2, 2017; and

WHEREAS, it is in the best interests of the City of Crystal Lake that the Variation be granted as requested in said Application.

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF CRYSTAL LAKE, McHENRY COUNTY, ILLINOIS, as follows:

<u>SECTION I:</u> That a Variation be granted from the Crystal Lake Unified Development Ordinance to allow the construction of a shed on an existing slab 3 feet from the side yard lot line, a variation of 2 feet at the property located at 349 2nd Court (19-05-333-005), Crystal Lake, Illinois.

Background

• The site is located on the east side of Main Street, north of the Crystal Lake Business Center and between existing manufacturing uses.

- The majority of the property is still within McHenry County's jurisdiction. The site is zoned M Manufacturing and I-1 Industry(County).
- If the petitioner continues to proceed forward: Annexation, Comprehensive Land Use Plan Amendment, Rezoning, Preliminary Planned Unit Development, Preliminary Plat of Subdivision, and Variations would be necessary.

Conceptual Plan Highlights

- The proposed plan illustrates 360 units, with (36) 5-unit townhomes, (73) single-family lots and (107) row home single-family lots.
- Density variations would be necessary for all the products in the proposed project. Estimates are:

Townhome Area ~13 units/acre

UDO maximum is 9 units/acre

Single Family ~ 5.2 units/acre

UDO maximum is 4.15 units/acre

Rowhomes ~8.2 units/acre

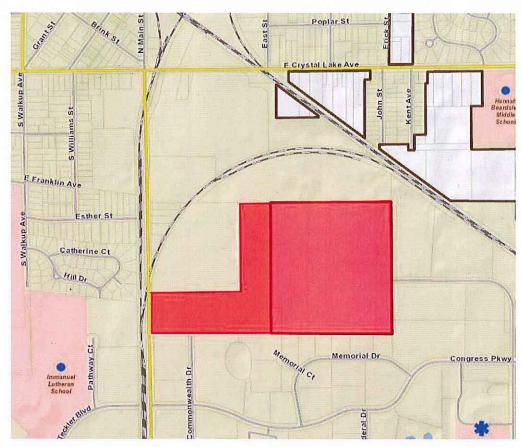
UDO maximum is 6.35 units/acre

PZC Discussion

- Staff made a presentation before the Planning and Zoning Commission highlighting best planning principles and how this plan could incorporate those principles.
 - o Sense of Place gathering focal point, Great Places have Great Spaces.

- o Short blocks walkability
- o Connected, meaningful green space for buffering
- The PZC questioned if resdiential uses were appropriate for this parcel and if the density was too high.
- If residential is acceptable here, the PZC was looking for a more diverse plan that could incorporate more amenities for the new residents.

Background:

The Illinois Transportation Enhancement Program (ITEP) provides funding for community based projects that expand travel choices and enhance the transportation experience by improving the cultural, historic, aesthetic, and environmental aspects of transportation infrastructure. This program is funded by the current federal transportation omnibus act known as Fixing America's Surface Transportation, or FAST. The program is administered by IDOT and IDOT is currently accepting applications for projects to fund through ITEP.

The City will be submitting a request to enhance the streetscaping at the Main Street and Crystal Lake Avenue intersection. The City is already working to improve this intersection. The construction of that improvement is funded through federal Surface Transportation Program (STP) funds, and includes some streetscaping elements. The Phase I Preliminary Engineering has been submitted to IDOT for approval, and the Phase II Design Engineering has begun. The City would use ITEP funding to provide for improved streetscaping above what is currently included in the project, and would extend the streetscaping improvements present throughout the downtown to this intersection.

Possible elements could include:

- Northeast corner: Addition of a decorative stone wall and various trees, shrubs, grasses and perennials with the relocation of the existing sign at the northwest corner to this new location.
- Northwest corner: Addition of various shrubs and perennials.

- Southwest corner: New kiosk to direct people using the Prairie Path to the various downtown amenities, extension of the existing brick pavers north of Crystal Lake Avenue, and decorative lighting.
- Southeast corner: Naturalization of the existing detention basin, various trees, shrubs, grasses and perennials.

The Council is requested to adopt the attached resolution so that it may be included in the application. The City is also seeking letters of support from Downtown Crystal Lake/Main Street and Willow Creek Church. ITEP can fund up to 80 percent of the costs of the project. The City applied for ITEP funding for this project last year, but the project was not selected.

The City would be responsible for the balance of the funding, which is estimated to be around \$20,000 to \$30,000. This would be paid for using MFT funds in next year's budget, if approved by the City Council. The entire design and plan will be brought to the City Council in the future for Council's review and direction.

Background:

On November 14, 2017, the City of Crystal Lake publicly opened and read aloud the bids received for a one-year contract for the purchase and delivery of clear southern rock salt. Clear southern rock salt is used daily by the Public Works Department for the City's water softening processes at all water treatment plants. The City expects to use approximately 3,500 tons of rock salt during the term of this contract.

The following is a breakdown of the bids received:

Discussion:

Midwest Salt submitted the lowest bid price for Clear southern rock salt. The delivery of this product will begin in 2018. In 2017, the City paid \$108 per ton.

Recommendation:

The Public Works Department has reviewed the bid received for completeness and accuracy. Midwest Salt has provided salt to the City of Crystal Lake in past years and they have been a responsive supplier. Therefore, it is staff's recommendation to award the contract for clear southern rock salt to the lowest responsive and responsible bidder, Midwest Salt, in the amount of \$97.00 per ton for the base year. Funds were budgeted for this purchase.

BOUNDARY LINE AGREEMENT - WOODSTOCK

Recommendation:

City Council's discretion.

Discussion:

The City of Crystal Lake and City of Woodstock have a boundary line agreement (attached), which is set to expire 12/03/17. The original agreement, which lasts for twenty years, was approved December 3, 1996 and was renewed last year for one year to allow time for the municipalities to consider if they'd like to extend the agreement.

When the Boundary Line Agreement was approved, the boundary line closely followed the facility planning area (FPA) line that was determined by the IEPA, based on a review of the sanitary sewer servicing capacity of the respective municipalities. The FPA lines were treated as formal, jurisdictional boundary lines that determined which community a development would build in. FPAs no longer serve as a determination for development siting decisions. That being said, most developers that the City talks with are mostly concerned about the City's ability to provide sewer and water for development. Currently, the City does not have a lot of extra sewer capacity to serve new development to the northwest unless improvements are made to the City's conveyance system.

The City of Woodstock conducted a special Council Workshop (info attached) to discuss expiring boundary line agreements and pre-annexation agreements. From their proposed changes to the boundary line with Crystal Lake, it appears that Woodstock is desirous of expanding its municipal limits along Route 14, to incorporate approximately 24 acres along Route 14, south of Lily Pond Road, pictured below.



Also, approximately 37 acres located east of Doty Road, pictured below.



Woodstock's Comprehensive Land Use Plan calls for buffer areas around the City, to preserve the open space and farmland gateway to their community.

The attached map illustrates the current incorporated limits of both Crystal Lake and Woodstock, the current boundary line, in red, and the proposed boundary line changes by Woodstock, in white.

Staff Recommendation

As the FPA system for sanitary sewer capacity has been eliminated, the general basis for a boundary line agreement is gone. Staff continues to market the available land nearby McHenry

County College for tech-industrial type uses. At this time, based on the available information, it is recommended that the Boundary Line Agreement with Woodstock be allowed to expire.
