3. 2018-33 PLUM CREEK - Rt 14 & Ridgefield Rd - PUBLIC INTRO MEETING

A motion is requested to set a public hearing date of July 18, 2018

Preliminary Plat of Subdivision for 53 lots and 3 outlots, Comprehensive Land Use Plan Amendment from Office to Residential and Office, and a Preliminary Planned Unit Development for a multi-family senior development.
