RE: Executive Order in Response to COVID-19

DATE: March 16, 2020 Time: 5:30 p.m.

This is an update regarding Governor Pritzker's Executive Order to facilitate social distancing and reduce the spread of COVID-19. As of 9:00 p.m. today, Governor Pritzker has ordered that all businesses that offer food or beverages for on-premises consumption – including restaurants, bars, grocery stores, and food halls – must suspend service for and may not permit on-premises consumption.

Please adhere to the following guidelines:

- Such business are permitted and encouraged to serve food and beverages so that they may be consumed off-premises through such means as in-house delivery, third party delivery, drive through, and curbside pick-up.
- Customers may enter the premises to purchase food or beverages for carry-out. However, establishments offering carry-out including food trucks, must ensure they have an environment where patrons maintain adequate social distancing.
- Businesses located in airports, hospitals, and dining halls in colleges are exempt from these requirements.
- Hotel restaurants may continue to provide room service and carry-out.
- Catering services may continue.
