- 15. 997 North Shore Drive Variations from Article 3 to allow the encroachment of the principal structure 10 feet 3 inches into the 106.98 street side setback, allow the encroachment of the principal structure 15 feet 3 inches into the 59.27-foot front yard (lake side) setback, allow a three-foot encroachment by a roof overhang over the bay windows, a one-foot variation, the construction of an accessory structure (a raised patio and spa with retaining wall), which encroaches an additional 11

- feet into the 59.27-foot, a variation of 26 feet, and to allow a total impervious surface coverage of 59%, a variation of 9% or 1,053 square feet
