

#2014-57 UDO Text Amendment (Vapor Lounge) Project Review for Planning and Zoning Commission

Zoning Request: UDO Text Amendment to allow Vapor Lounges as part of an e-

cigarette retail location in the B-2 and B-4 zoning districts.

Background:

• Recently, the City Council discussed the use of electronic cigarettes and similar products in public areas. This proposed text amendment is intended to correlate with Council's discussion on this topic.

- Currently, the UDO does not permit smoking lounges. There is not a category or definition for a vapor lounge. This text amendment would clarify that use.
- The following outlines the proposed changes to the UDO for this request.

Article 2-Land Use

Section 2-300 Permitted Uses Table

The proposed text amendment would allow a Vapor Lounge, but only when ancillary to an ecigarette retail store. E-Cigarette retail stores fall under "All Other Miscellaneous Store Retailers."

Article 10-Definitions

ELECTRONIC CIGARETTE / **E-CIGARETTE**: Any electronically actuated device which in operation causes the user to exhale any smoke, vapor, or other substance other than those produced by unenhanced human exhalation. "Electronic cigarette" or "e-cigarette" includes any such device, whether manufactured, distributed, marketed, or sold as an electronic cigarette, an electronic cigar, an electronic cigarillo, an electronic pipe, an electronic hookah, or under any other

product name or descriptor. The term "electronic cigarette" does not include any asthma inhaler or other device that has been specifically approved by the United States Food and Drug Administration.

E-CIGARETTE RETAIL STORE: A retail establishment that derives more than 80% of its gross revenue from the sale of electronic cigarettes and related products, and in which the sale of other products is merely incidental. "Electronic Cigarette Retail Store" does not include an ecigarette department or section of a larger commercial establishment or any establishment with any type of liquor, food, or restaurant license.

VAPE: To inhale and exhale the vapor from an e-cigarette.

VAPOR LOUNGE: An area with seating and tables where customers of an electronic cigarette retail store may vape or sample electronic cigarette products before purchase.

Recommended Action:

To approve the UDO Text Amendment for vapor lounges.
